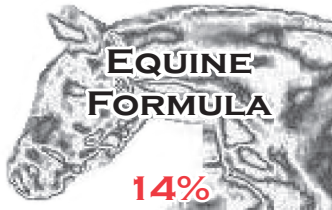

GALLIUM NITRATE BONE & JOINT SUPPORT

ANTI - INFLAMMATORY PAIN RELIEF



CONCENTRATE

DRUG FACTS:

INTENDED USE: This product supports healthy foot bones and joints in horses by inhibiting osteoclast action and resorption of bone, by stimulating bone formation through action on osteoblasts (bone forming cells) and by providing anti-inflammatory, anti-aluminum bacteriostatic and anti-pain benefits.*

NET CONTENTS: 70 grams of gallium nitrate in 500 ml water (19 grams elemental gallium) .

BEFORE USE, THIS CONCENTRATE MUST BE DILUTED TO A ONE PERCENT (1%) SOLUTION.

TO MAKE A ONE PERCENT SOLUTION: Using a syringe, add 36 CC of the 14% CONCENTRATE to a pint of water to make a single daily dose for a 1200 pound horse. This dilution will contain one percent (1.0%) gallium nitrate. Equivalences: One pint = 1/2 liter = 500 mL = 500 CC.

DOSAGE FOR A 1200 POUND HORSE: Add one pint of the one percent solution to the horse's feed each day for a minimum of 90 days, and preferably for 6 months. For long term maintenance after the first 6 months, daily dose might be reduced by half. Do not greatly exceed recommended daily dosage. Proportionately adjust dosage for substantially lighter and heavier horses.

WARNINGS: There is a possibility of overly exuberant behavior on first turnout. This product is not intended for pregnant, lactating, breeding or food production horses. Keep product out of reach of children and animals. To prevent pain, do not allow CONCENTRATE to contact mouth or eyes of humans or animals. In case of mouth or eye contact, rinse thoroughly with clean water for at least 15 minutes. Absorption of gallium nitrate solutions through the skin is rapid. Skin contact with the CONCENTRATE may cause itching, stinging and/or exfoliation if not washed from skin.

OTHER INFORMATION: Label the daily dosage bottle of diluted gallium nitrate with the words: "ONE PERCENT GALLIUM NITRATE". Store containers in a safe, dry place. Freezing will not harm this material. Keep container sealed. CAS#13494-90-1 MSDS available at <http://galliumnitrate.com>.
